Pursuant to the provisions of Section 91 of the Companies Act, 2013 and Clause 16 of the Listing Agreement with Stock Exchange(s), the Register of Members and the Share Transfer books of the Company shall remain closed from Tuesday, September 8, 2015 to Monday, September 14, 2015 (both days inclusive) for the said AGM and for payment of Dividend, if approved at the ensuing AGM.
