## SUMMARY OF PROCEEDINGS OF THE 48TH ANNUAL GENERAL MEETING

The 48th Annual General Meeting (the "AGM") of the Members of JD Orgochem Limited (the "Company") was held on Monday, 08th August, 2022 at 3.00 P.M.
